#### A. ESTIMATED COST OF TENDER & BID SECURITY/EMD

The estimated cost of the scope envisaged in this Tender Document is **Rs. 13 Lakhs.** The EMD in the form of Demand Draft, drawn in favor of the Director, IIIT, Nagpur for an amount of Rs. **32,500/-** to be invariably enclosed with the tender in a separately sealed envelope.

Alternatively, the EMD Amount can also be paid online in the Institute Bank Account details of which are provided in the tender document. Bidders registered with NSIC, MSMEs etc are exempted from payment of EMD subject to submission of documentary evidence.

#### **B. PAYMENT OF TENDER FEES**

All the Bidders shall be required to submit Tender Form/Tender Processing Fees in the form of a Bank Draft of Rs. 2,360/- (Rs. Two Thousand Three Hundred and Sixty Only) drawn in favour of The Director, IIIT, Nagpur and payable at Nagpur.

The Bidder is required to write name of the Company on back side of the Demand Draft or NEFT/RTGS Receipt. A copy of the receipt is to be attached with the hard copy of the submitted Bid.

The Tender Form/Tender Processing Fee is non-refundable.

#### C. TENTATIVE COMMENCEMENT OF CONTRACT

The Successful Bidder shall have to "Undertake the Maintenance Contract of Networking Devices including SERVER & Wi-Fi System for 5 Years" at IIIT, Nagpur immediately from the date of issue of work order by the Institute.

The Director, IIITN shall have the sole authority to reschedule the date of providing services if required. The decision of the Director, IIITN shall be final in this matter.

#### D. TENTATIVE REQUIREMENT

The work shall be awarded to the Successful Bidder. Detailed Specifications As per **Detail Scope** of Work.

#### E. ELIGIBILITY CRITERIA

The Bidder, fulfilling the following criteria shall be eligible to apply:

- 1) The Bidder must have a **minimum of Five Years of experience** of the Maintenance of L2 & L3 Switches of CISCO/Juniper/others Make in CFTIs/IITs/NITs/IIITs/ Any other Government Organization.
- 2) The Bidder must have a **minimum average annual turnover of Rs. 45 Lakhs** for the Five years i. e (FY 2017-18, 2018-19, 2019- 20, 2020-21 and 2021-22).
- 3) They must have the following registrations:
  - a. Goods and Services Tax (GST)
  - b. Income Tax (PAN)
  - c. Shop and Establishment Registration (Gumasta)

Bidders are requested to note that in case of non-availability of any of the mentioned Registration, the Institute may decide to reject the Bid summarily. The decision of the Competent Authority on this shall be binding.

- 4) The Bidder must be in a position to provide 24x7 Service Support to the Institute and should have a local team at Nagpur.
- 5) The Bidder should not have been debarred and/ or blacklisted by any Central Government / or any State Government / Autonomous Department(s) / Body as on the last date of submission of the Tender.
- 6) The bidder must be an authorized partner and provide a certificate of authorization specific to the tender from each OEM.
- 7) For five years following the contract's award, the bidder is required to submit the original service/support contract/warranty papers of Cisco, Juniper.

#### F. GENERAL CONDITIONS OF TENDER

- 1. The Institute reserves the right to reject any or all tenders, wholly or partly or close the tender at any stage prior to the award of the contract without assigning any reason whatsoever.
- 2. The Institute reserves the right to carry out the capability assessment of the Bidders and the Director, IIITN decision shall be final in this regard.
- 3. The bid of any bidder who has not complied with one or more of the conditions of eligibility criteria and/or fails to submit the required documents as required / or mentioned in the tender document is liable to be summarily rejected.
- 4. It shall be the responsibility on the Bidder to fully inform / acquaint / familiarize itself with local conditions and factors, which may have any effect on the execution of supply and services to be rendered under the Tender. All Bidder (s) intending to bid shall visit, if required to the IIITN Permanent Campus and make themselves thoroughly acquainted with the local site conditions.
- 5. The Institute shall presume that the Bidder has understood and agreed that all the relevant factors have been kept in view while submitting the bid. No financial adjustment arising

- thereof shall be permitted by Institute, on the basis of any non-clarity of information about local conditions being pleaded by the bidder.
- 6. Liaising, if required, with an outside Agency/Government Authority for undertaking & delivering any or all supply & services stipulated under this Tender, shall be the sole responsibility of the Bidder.
- 7. The Bidder would ensure that all the applicable rules & regulations of Central/State/Local Authority shall be strictly followed wherever applicable.
- 8. The bidder shall give 5 years warranty for the items supplied and installation work carried out.
- 9. The Financial / Price Bid(s) shall be evaluated on the basis of the quoted price in accordance with the Price Bid Format provided in the Tender Document.

The <u>Lowest Bidder (L1)</u> shall be awarded the Work Contract subject to fulfilment of all the conditions of the Tender.

#### G. BID PRICE:

The work shall be as described in the **Detail Scope of Work.** Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.

#### H. SINGLE BID BY INDIVIDUAL BIDDER:

Each Bidder shall submit only one bid.

#### I. VALIDITY OF TENDER

Tender shall remain valid for a period of not less than 180 days after the deadline date specified for submission.

#### J. EVALUATION OF BIDS:

IIIT Nagpur will evaluate and compare the tender(s) determined to be substantially responsive i.e., which:

- a) Are properly signed & submitted in original; and
- b) Confirm to the terms & conditions, of the tender.

Conditional Tenders and late submitted Tenders will not be accepted.

#### K. BID SYSTEM AND INSTRUCTIONS FOR SUBMISSION OF BIDS:

"Two Bid" Systems will be followed for this tender. Two sealed envelopes, namely. "Technical Bid" and "Financial Bid" are to be put in one sealed envelope super-scribed with "Maintenance Contract of Networking Devices including SERVER & Wi-Fi System for 5 Years" at IIIT NAGPUR.

#### The Contents of "Technical Bid":

The qualification bid should be placed in a sealed cover. This envelope should be super-scribed "Maintenance Contract of Networking Devices including SERVER & Wi-Fi System for 5 Years" at IIIT NAGPUR.

The envelope containing the Technical / Qualifying Bid should also contain the EMD in the form of Demand Draft (DD) drawn in favour of Director, IIIT Nagpur. Technical Bid should have proper indexing along with page no. mentioned. Technical bid should contain papers as per Technical Bid Check list. Failing which tender will be out rightly rejected.

- 1. The technical bid will include all technical and associated supporting documents, indicating the compliance of technical specifications as per the tender.
- 2. It is essential to fill complete forms as per prescribed format only to qualify the technical bid. Incomplete forms should be summarily rejected. If needed separate sheet should be enclosed for furnishing complete details. Any other format will lead to disqualification.

#### The Contents of "Financial Bid":

- 1. Item wise rate should be indicated in the prescribed format in the financial Bid only.
- 2. Each cover should also indicate clearly the name and address of the bidder and tender no.

#### SELECTION CRITERION IN CASE OF TIE OF SAME RATES OF L1

1. Bidder having higher Average Annual Turnover for last 5 years (FY 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22) (as per submitted documents) will be selected.

#### L. AWARD OF WORK:

The IIIT Nagpur will award the work to the bidder, whose tender has been determined to be substantially responsive, and who has offered the lowest rate.

- 1. Notwithstanding the above, the IIIT Nagpur reserves the right to accept or reject any tender(s) and to cancel the bidding process and reject all tenders at any time prior to the award of work.
- 2. The bidder whose bid is accepted will be notified of the award of work, by the IIIT Nagpur / prior to expiration of the Tender validity period. The terms of the accepted offer shall be incorporated in the work order.

#### M. SECURITY DEPOSIT:

The Selected Bidder shall be required to submit a Security Deposit within 10 Days from the date of receipt of the Intimation Letter from the Institute for an amount equal to 10% of accepted cost including applicable taxes and duties.

The Accepted Cost shall be the price quoted by the Selected Bidder in the Financial / Price Bid including the applicable taxes and duties.

The Security Deposit shall be furnished in the form of Demand Draft of any Scheduled Bank drawn in favour of the Director, IIIT Nagpur and payable at Nagpur. This Security Deposit shall remain with the Institute, interest free, as Security for the entire duration of the Contract and will

be replenished from time to time in case of deductions, if any, by the Institute towards recovery from the Agency. The aforesaid Security Deposit shall be returned to the Agency after 60 days or expiry of the contract without any interest, after deductions, if any, made by the Institute.

In the event of the Selected Bidder is failure to "Maintenance Contract of Networking Devices including SERVER & Wi-Fi System for 5 Years" at IIIT NAGPUR or the services as per the contract, the Institute reserves the right to hire Supply, Installation and Commissioning of Networking Devices including SERVER at IIIT NAGPUR from other sources at the Selected Bidder's risk and cost and all such expenses and losses incurred by the Institute in this regard shall be borne by the Selected Bidder. Further, the Institute shall retain the right of forfeiture of Security Deposit and or any other action(s) as deemed fit.

#### N. PAYMENT TERMS & CONDITIONS:

#### Quarterly payment will be released after satisfactory work completion

#### **Terms of Payment**

(i) The Payment will be made on a quarterly basis on the generation of a satisfactory service completion certificate from the Competent Authority of the Institute.

#### O. PENALTY

- (i) If the Bidder fails to provide the Certified manpower as required in the Tender Document within the stipulated period(s) specified in the Contract, IIITN shall deduct as penalty, a sum equivalent to 0.5 percent of the delivered Contract value for 24 hours or part thereof of delay, up to a maximum deduction of 10% Percent of the Contract value. Once the maximum is reached, the Purchaser may consider termination of the Contract.
- (ii) If the Bidder fails to rectify any hardware/network/application/ configuration problem within the stipulated period(s) of 48hours from logging of the complaint in which no spare/part replacement/repair is required, the IIITN shall, deduct a penalty of sum equivalent to 0.2 percent of the delivered Contract value for 48 hours or part thereof of delay, up to a maximum deduction of 5% Percent of the Contract value. Once the maximum is reached, the Purchaser may consider termination of the Contract.
- (iii) If the Bidder fails to rectify any defect due to non-availability of spares/parts within the stipulated period(s) of 72 hours (15days in case of parts which require import) from logging of the complaint, the IIITN shall, deduct a penalty, as sum equivalent to 0.2 percent of the delivered Contract value for the specified time or part thereof of delay, up to a maximum deduction of 5% Percent of the Contract value. Once the maximum is reached, the Purchaser may consider termination of the Contract.
- (iv) In case, the bidder fails to provide spare repair/replacement within the specified maximum time of 15 days, IIIT NAGPUR, would-be free to get the part repaired/replaced from any third party and payment will be done by the bidder apart from applying penalty as per the above clause (iii).

(v) All the complaints will be attended within 4 hours and the bidder will have to ensure minimum uptime of 95% in a month and 97% in one year. The uptime will be calculated in number of days in a year and number of hours in a day. If the total downtime exceeds 5% in a month or 3% in one year, the IIITN shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as penalty, a sum equivalent to 1 percent of the delivered Contract value for each 1% of the downtime, up to a maximum deduction of 5% Percent of the Contract value. Once the maximum is reached, the IIITN may consider termination of the Contract.

Any amendment or corrigendum regarding the Tender will be issued on the Institute Website only. For any disputes, the place of jurisdiction shall be Nagpur, Maharashtra (India) only.

The work includes the following:

- 1. Comprehensive Maintenance of Active networking equipment which includes annual preventive and remedial maintenance of the active network components. It will also include the supply and replacement of parts as and when required.
- 2. Relocation and setup of server room as and when required as per the Institute needs.
- 3. Maintenance of Proxy DNS, Backup Servers including firewall & application support.
- 4. Maintenance and configuration of existing servers.
- 5. Reconfiguration of existing network & its validation as per requirements.
- 6. Quarterly Preventive Maintenance of all of the equipment listed in Annexure: A-1, Annexure: A-2, and Annexure: A-3.
- 7. All the devices/components mentioned in **Annexure: A-1, Annexure: A-2, and Annexure: A-3** should be functional 24x7x365days and the bidder/tenderer would be responsible for the same.

#### **General Terms & Conditions**

- 1. Necessary licence, permit, consent, sanction, etc. as may be required or called for from/by local or any other authority for doing such work shall be obtained.
