- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. - 1. Administrative & Technical manpower is to be provided as per requirement of IIIT Nagpur and the numb er of persons required may vary from time to time.
- 2. The requirement of manpower to be deployed / hired at IIIT Nagpur will be at sole discretion of the Direc tor IIIT Nagpur. The method of selection of manpower to be deployed at IIIT Nagpur along with their qualification and experience will be decided by Director IIIT Nagpur.
- 3. IIIT Nagpur shall provide the list of the Office staff to be deployed / hired through the selected Manpower Supply Agency for further processing.
- 4. The new service provider shall ensure that he takes over all responsibilities of the person deployed by e arlier agency for smooth transfer related to all statutory requirements like IT, EPF, PT etc including issuing appointment letters to these deployed persons. In case of non compliance, the security deposit shall be for feited.
- 5. The agency shall deploy the staff for a contract period of 11 months with effect from the contract comm encement date.
- 6. Any further addition to the staff shall be for a contract period of 11 months from the date of joining.
- 7. The renewal of the contract period of all the deputed staff shall be at the sole discretion of the Compete nt Authority of IIIT Nagpur.
- 8. Initially the work shall be awarded to the Successful Bidder for Twelve Months. The period shall be exten dable by another Twelve (12) Months subject to appraisal & performance review by the Institute Authoritie s. The Services may be further extended for another period of One Year with mutual consent of both the Parties subject to appraisal & performance review by the Institute Authorities i.e. maximum period of 3 Years
