#### A. SCOPE OF WORK: -

The total length of the sewer line between the Administration Building and the Sewage Treatment Plant (STP) is approximately 685 meters.

- 1. Desilting and removal of sludge, oil, and grease from manhole chambers.
- 2. High-pressure jetting and suction cleaning of sewer lines.
- **3.** Proper disposal of extracted waste as per environmental norms.
- 4. Disinfection of manholes and cleaned pipelines to maintain hygiene.
- 5. The contractor shall deploy Combined Suction & Jetting Machines with fitted with pump having 4000 liters suction capacity and 6000 liters water jetting tank capacity.
- **6.** Two service visits per year under the AMC.

#### **B. GENERAL TERMS AND CONDITIONS: -**

- 1. The successful Bidder / Contractor shall observe all safety regulations and take necessary safety precaution.
- 2. The contract will be initially for a period of one year, if the performance / service is found satisfactory the contract may be extended for a further period of 02 Years depending on the performance at same rate, terms and condition.
- 3. The payment shall be released only after successful completion of the work & obtaining satisfactory report from the Competent Authority of the Institute on half yearly basis after the completion of service.
- 4. The successful Bidder / Contractor has to carry out manhole chamber desilting and sewer line cleaning on a half-yearly basis using Suction & Jetting Machines as per given in s+cope of work.
- 5. The contractor shall deploy trained and experienced operators to handle the Suction and Jetting Machine. The deployed machine/vehicle must also possess all valid and complete documents.
- 6. Contractor shall provide emergency blockage removal services as and when required.
- 7. Intending bidders are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting their quotations.
- 8. The time allowed for the work shall be strictly followed otherwise the Selected Bidder shall be liable to pay compensation at the rate of 0.5% of the quoted Price of the work per week of delay on the part of the Selected Bidder subject to a maximum of 10% of the total Contract Value.
