**Quantum of Finance**: For students of IITs/NITs/IISc / IIIT – Limit Upto Rs. 30 lacs
For students of IIMs- Upto Rs. 40 lacs
For students of ISB- Upto Rs. 50 lacs.

**Expenses covered**: Loan to be considered Expenses on account of:

- Fee payable to college/ hostel.
- Examination/ Library/ Laboratory fee
- Insurance premium for student borrower, if applicable
- Caution deposit, building fund/refundable deposit supported
- by Institution bills/receipts.
- Purchase of books/ equipment's/ instruments/ uniforms
  - Purchase of computer/ Laptop at reasonable cost,
